### Increased Pharmaceutical Spending

With a rapidly aging population demographic, Korea will rank as the second-oldest country in the world by 2050. Government spending on health care and the demand for international pharmaceutical ingredient suppliers will increase, particularly for those with chronic diseases such as diabetes, arthritis, cardiovascular problems, and blood pressure.



### Ranked #6 - Clinical Trials

Korea ranked 6th in the world for the number of clinical trials conducted in the country, and Seoul topped the list with the most clinical trials per city since 2017. The fast start-up time, world-class expertise, and well-defined regulatory and review processes continue to make Korea a growing global destination to conduct clinical trials.



### Powerhouse of Biopharmaceuticals

Korea has achieved remarkable growth in the global biopharmaceutical industry and is becoming a global biopharmaceutical power based on its advanced IT technology, superior development and production capabilities, and the mutual collaboration between overseas and domestic companies.



### Advanced Production- Management System

Advanced production and quality management systems are factors that make Korea's pharmaceutical industry globally competitive. MFDS joined the PIC/s in 2014 and became the sixth regulatory member of ICH in 2016. Furthermore, after meeting the EU's standards, Korea became the seventh country to be listed on the EU's "whitelist" in 2019.

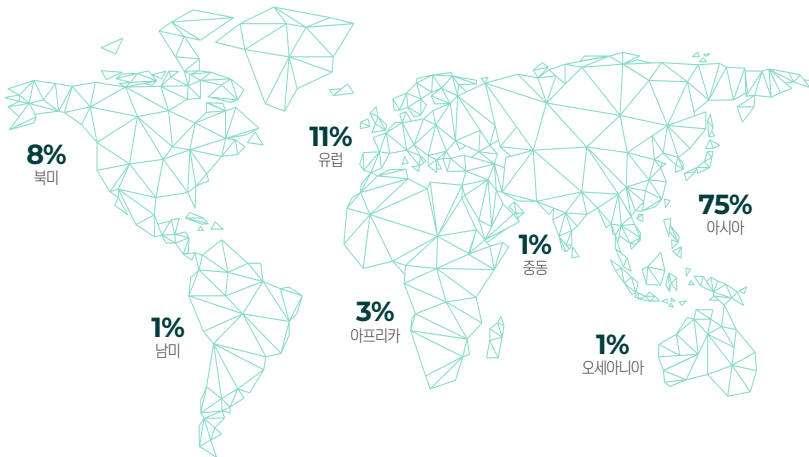
